Summary and Overall Rating

Coral Park Elementary serves PreK through fifth grade in Westchester, Miami. The school achieves strong academic outcomes with approximately 69 percent proficiency in math and 71 percent in reading. It typically earns an 8 out of 10 rating from review platforms and ranks among the top elementary schools in the region.

However, recent concerns have emerged, including complaints about cafeteria staff behavior and limits on therapy access for special-needs students. The school follows district-wide policies on gender identity and LGBTQ inclusion, requiring staff to respect student pronouns without an opt-out option.

From a traditional or faith-based perspective, Coral Park Elementary receives a **3.5 out of 10** rating for overall alignment with conservative educational values. The academic foundation is strong, but issues around emotional safety, supervision, and ideological policies may be areas of concern.

1. Academic Standing & Programs

Coral Park is academically strong with above-average proficiency rates in core subjects. The school is consistently recognized for achievement and offers:

- Gifted and Talented classes
- Enrichment through music, arts, and STEM labs
- Dedicated reading intervention programs
- After-school clubs including robotics and multilingual support

These programs support both high-achieving students and those needing academic reinforcement.

2. Student Community & Support Services

With around 890 students and a student-teacher ratio of approximately 16 to 1, the student body is predominantly Hispanic, with about half qualifying for free or reduced-price lunch. The school offers:

- English language learning support
- Special education services and behavior specialists
- Guidance counselor access
- School climate surveys to identify student emotional and social well-being

The PTA hosts workshops for parents on topics such as cyber safety, reading strategies, and mental health resources.

3. Facilities & Learning Environment

The campus is equipped with:

- Standard and STEAM-enhanced classrooms
- A well-stocked library and media center
- After-school care and enrichment programs
- Regular parent engagement through science fairs, family reading nights, and PTA-hosted events

Outdoor play areas are maintained, and regular safety drills are conducted.

4. Values & Cultural Environment

Coral Park follows district policies that require staff to honor students' preferred names and pronouns without a parent opt-out. Staff receive training in LGBTQ affirming practices. While

the school does not promote activism or identity-focused campaigns, the use of preferred pronouns and inclusive language is present.

5. Recent Concerns or Incidents

Several issues have been reported by parents, including:

- A cafeteria monitor was removed following complaints of verbal or emotional mistreatment reported by students
- Parents of special-needs students have experienced restrictions in accessing therapy and related services
- Concerns have been raised about grievance filing and how responsive the school's administration is to parental feedback

School leadership has responded with staff retraining, updated supervision policies, and more open communication with families.

6. Political Context & Policies

In 2022, the district board voted against recognizing LGBTQ History Month in high schools, but elementary schools like Coral Park remain under district-wide policies that require staff to respect gender identity and orientation. Parent involvement and school board culture may influence how these policies are implemented locally.

7. Parent Concerns

Families with traditional or faith-based values may wish to consider:

- Presence of identity-related protocols in early grades without opt-out options
- Emotional safety and staff supervision due to reported incidents
- Accessibility of therapy and special support services
- Desire for clearer communication and stronger channels for raising concerns

8. Helpful Tips for Parents

To ensure clarity and alignment with family values, consider:

- Attending PTA and school climate meetings regularly
- Scheduling an early- year conference with the principal to understand protocols
- Asking for the school's family advocacy or grievances guidelines
- Joining parent communication groups to stay informed on quick updates
- Checking safety logs, incident reports, and response protocols

These actions can help parents actively participate in shaping a positive school experience.
