Gulfstream Elementary School serves PreK through fifth grade in Sunny Isles Beach. The school enrolls approximately 350 students with a class size of around sixteen students per teacher. Academic proficiency is strong, with nearly seventy-eight percent proficiency in math and seventy percent in reading. Despite strong academics, district policies on identity may raise concerns for parents. Based on those values the school receives a **rating of 3.5 out of 10**.

1. Student Demographics & Support Services

The student population is about sixty-five percent Hispanic, twenty-five percent White, and ten percent Asian or other backgrounds. About forty percent of students qualify for free or reduced price lunch. Support services include Gifted and Talented instruction, ESL classes, special education services, reading and math interventions, and school counseling.

2. Academic Standing & Programs

The school demonstrates high academic performance with strong test scores in reading and math. Specialty programs include monthly STEAM labs, art enrichment, music, and science fairs. After-school tutoring, literacy nights, and instructional coaching support student achievement and enrichment opportunities.

3. Facilities & Learning Environment

Campus features include updated classrooms, a media center, technology labs, and secure outdoor areas. Family engagement events include reading nights, arts performances, and community academic showcases. Staff maintain robust safety procedures during arrival and dismissal times.

4. Values & Policy Environment

District policy requires staff to respect student preferred pronouns and names from the earliest grades, classifying gender identity as a protected category. There is no formal LGBTQ curriculum at the elementary level; however inclusive language may appear in counseling or announcements. Parents concerned about early exposure may wish to clarify how these policies are practiced and how family values are taken into account.

5. Bathroom Policy & Privacy

Restroom facilities are conventional and separated by gender. Boys and girls use their own restrooms under standard adult supervision. There is no evidence of shared or unisex bathroom access. Parents may confirm layout and supervision during a school visit.

6. Recent Incidents or Concerns

There are no serious safety or misconduct incidents publicly reported. Parents mention occasional delays in communication about minor behavioral matters. School leadership has responded by improving notification protocols and reinforcing discipline procedures.

7. Parent Engagement & Communication

Parents can stay involved through advisory council meetings, Parent Academy workshops, classroom volunteer programs, and school events. Communications are provided via newsletters, apps, and direct messaging platforms. Most families report prompt responses and accessible staff, though some note occasional delays.

8. Parent Concerns & Suggested Actions

Parents with traditional or faith-based values may wish to consider:

- How pronoun and identity policies are introduced at early grade levels
- Availability of support for students needing academic reinforcement
- Methods for receiving updates on behavior or academic issues
- Ways to participate in school policy decisions or advisory councils

Suggested actions for parents:

Visit the school early in the year

Meet with principal or counselor to discuss academic supports and policy clarity

Volunteer in reading or enrichment events to observe school atmosphere
Review the parent handbook to understand discipline, attendance, and identity protocols

Final Summary for Parents

Gulfstream Elementary offers high academic performance, enrichment programs, and strong community engagement in a well-maintained and resource-rich setting. However district identity policies begin early and may not align with all family values. Parents are encouraged to visit the school, meet leadership and teachers, and see how policies are implemented to determine if Gulfstream aligns with their educational and cultural expectations.
