A Traditional Parent's Perspective on School Policies and Environment

Henry M. Flagler Elementary serves students in PreK through fifth grade in the Homestead area of Miami-Dade County. Enrollment is about 330 students, with an average class size of sixteen. Academic performance is modest with approximately fifty percent proficiency in both math and reading. Chronic absenteeism is notable at around twenty-eight percent. From a traditional or faith-based perspective the school receives a **rating of 3.5 out of 10**, due to academic and attendance challenges as well as district identity policies.

1. Student Demographics & Support Services

The student body is diverse, with approximately sixty percent Hispanic and thirty percent African American students. Roughly fifty-five percent of students qualify for free or reduced-price lunch. Support programs include ESL instruction, special education, reading intervention, counseling, academic coaching, and Title I resources.

2. Academic Standing & Programs

Academic offerings include Gifted and Talented instruction, STEAM activities, reading and math support groups, and after-school tutoring. Though proficiency rates are moderate, classroom aides and targeted interventions are used to help students meet grade-level expectations.

3. Facilities & Learning Environment

The campus includes standard classrooms, a media center, a STEM lab, and outdoor play areas. Arrival and dismissal routines are supervised by staff. Family literacy nights, science fairs, and student showcases help foster community involvement and engagement.

4. Values & Policy Environment

District policy classifies gender identity and sexual orientation as protected. Staff must respect student-preferred pronouns and names starting in early grades. There is no formal LGBTQ curriculum at the elementary level, but inclusive language may appear during counseling or general school announcements. Parents who prefer minimal exposure are advised to communicate with school leadership about how these policies are implemented and whether family values are reflected in classroom practices.

5. Bathroom Policy & Privacy

Restrooms at Flagler Elementary remain gender-segregated, with separate facilities for boys and girls. Adult supervision is standard in hallways but not inside restrooms. The school does not use shared or mixed restrooms. Parents may confirm current layouts during school tours or meetings.

6. Recent Incidents or Concerns

No serious safety threats or misconduct cases are publicly reported. Some parents mention occasional delays in communication following minor behavioral or academic issues. School administration has reportedly improved follow-up processes and attendance monitoring in response.

7. Parent Engagement & Communication

Parents may connect via advisory council meetings, Parent Academy workshops, volunteer in classrooms, or participate in reading nights and enrichment events. Communication is typically sent through newsletters and messaging platforms. Many families report appreciative staff and reliable follow-through, though a few note occasional slow response times.

8. Parent Concerns & Suggested Actions

Families valuing traditional or faith-based environments may wish to review:

- How pronoun and identity policies are introduced in early grades
- Academic supports available for students needing extra help
- Communication procedures following incidents or attendance concerns
- Opportunities for involvement via advisory council or school leadership

Recommended steps for parents:

- Visit the school early in the year and speak with leadership about academics and policy
- Volunteer in reading or enrichment programs to observe classroom culture

- Ask for the parent handbook to review discipline and identity protocols
 - Engage in advisory roles to stay informed and request updates on school practices
