A Traditional Parent's Perspective on School Policies and Environment

North Hialeah Elementary School serves PreK through Fifth Grade in Hialeah. It enrolls approximately 441 students with a student teacher ratio of about seventeen to one. Academic performance is above district average with roughly 55 percent proficiency in math and 59 percent proficiency in reading. Chronic absenteeism remains a concern, ranging between 28 and 31 percent. From a traditional or faith based perspective the school receives a **rating of 3.5 out of 10**, reflecting moderate academic performance, attendance challenges, and district identity policies that may not align with all families.

1. Student Demographics and Support Services

- The student body is approximately 99 percent minority, primarily Hispanic
- Roughly 70 to 83 percent qualify for free or reduced price lunch

Support includes ESOL instruction, special education, small group tutoring, counseling, Gifted and Talented programming, and Title I funded academic support

2. Academic Standing and Programs

- Math proficiency averages around 55 percent and reading proficiency around 59 percent
- Science proficiency is lower, approximately 40 to 44 percent, reflecting mixed performance across subjects
- The school offers standard core curriculum alongside support programs and occasional enrichment opportunities

3. Facilities and Learning Environment

The campus includes classrooms and resource areas with supervised outdoor zones. Arrival and dismissal procedures are staffed for student safety. Community events such as family movie nights strengthen home school connections

4. Values and Policy Environment

District policy identifies gender identity and sexual orientation as protected categories. Staff are required to use student-preferred names and pronouns beginning in PreK with no parental opt-out option. While no formal LGBTQ curriculum is delivered in early grades, inclusive language may appear during counseling or general communications. Parents may wish to clarify how these policies are applied in classroom settings

5. Bathroom Policy and Privacy

Restrooms are gender segregated with designated facilities for boys and girls. Adult supervision is maintained in corridors and common areas. No gender-neutral or shared bathroom setups are in use. Parents may request a campus tour to review facility layout

6. Recent Issues of Note

Chronic absenteeism rates have ranged from approximately 28 to 31 percent in recent years, exceeding district norms. The school addresses attendance through incentive programs, monitoring, and family outreach. No significant safety or discipline controversies have been publicly noted

7. Religious Practices

School guidelines permit discussion of religious holidays as voluntary and age-appropriate. Appreciation of diverse beliefs is taught neutrally. A documented incident involved a second grader being asked to stop distributing religious pamphlets and having her bag searched, raising concerns about how personal faith expression is handled in peer-to-peer interactions

8. Parent Engagement and Communication

Parents are invited to attend family events, school advisory meetings, movie nights, and cultural activities. Communication is provided through newsletters and district messaging systems. Many families describe staff as caring, though some note delays in administrative response

9. Parent Concerns and Suggested Actions

Families with traditional or faith based values may wish to consider:

- How identity and pronoun protocols are introduced even in low grades
- The nature of academic instruction and support in reading or math
- School policies regarding student distribution of religious materials
- Communication methods following behavioral, attendance, or safety incidents

Recommended next steps for parents:

- Visit North Hialeah Elementary early in the year and speak with school leadership
 - Observe or attend family engagement events to evaluate culture firsthand
 - Request a copy of the parent handbook to review policies on identity, faith expression, discipline, and attendance
 - Monitor your child's academic and attendance progress and seek clarity on policy application as needed

Final Summary for Parents

North Hialeah Elementary provides a moderately performing academic environment with a strong Hispanic majority and supportive programming. Chronic absenteeism is a frequent concern and identity policies are enforced early. A recent incident highlighted school enforcement of limits on student religious distribution. Gender specific restrooms remain standard. Parents interested in traditional values and strong communication should tour the school, speak directly with leadership about policy implementation, and stay actively engaged in their child's progress.
