# A Traditional Parent's Perspective on School Policies and Environment

Perrine Academy of the Arts serves students from PreK through Fifth Grade in Palmetto Bay. The school enrolls approximately 410 students with a student teacher ratio of about fifteen to one. Academic performance is near district average, with around 48 percent proficiency in math and 47 percent in reading. From a traditional or faith based perspective the school receives a rating of 4.5 out of 10 due to moderate academic outcomes and district wide gender identity policies that may concern some families.

#### 1. Student Demographics and Support Services

- The student body is approximately 76 percent Black, 20 percent Hispanic, 3 percent White, and 1 percent multiracial
- Around 85 percent of students qualify for free or reduced price lunch Support services include gifted education, special education, Title I academic supports, counseling, and arts based enrichment opportunities

# 2. Academic Standing and Programs

- Math proficiency is about 48 percent and reading proficiency around 47 percent
- The school specializes in the visual and performing arts including music, dance, theater, and art integration across subjects
- Instruction includes differentiated support, test preparation, and extended day tutoring

#### 3. Facilities and Learning Environment

The campus features an auditorium, music and art rooms, outdoor play areas, and standard

classrooms. Arts focused spaces are central to the school identity. Safety measures are in place for arrivals, dismissals, and events

#### 4. Values and Policy Environment

District guidelines require recognition of student selected gender identity and pronouns starting in PreK with no parental opt out. While LGBTQ topics are not formally taught in early grades, inclusive references may occur during counseling or peer interactions. Families with traditional views may wish to clarify specific classroom practices

## 5. Bathroom Policy and Privacy

Restrooms are separated by gender and monitored by staff. No coed or gender neutral bathrooms are in use. Safety in hallways and shared areas is supported through supervision and staff protocols

#### 6. Recent Issues of Note

There are no major incidents or disciplinary issues publicly reported. Academic progress is stable but not exceptional. Chronic absenteeism figures are not clearly published. Continued district monitoring focuses on academic growth and community support

#### 7. Religious Practices

There are no documented conflicts involving religious practices. Students are allowed to engage in personal religious expression during non instructional times such as lunch or recess. There are no known objections by staff to student prayer or religious attire

#### 8. Parent Engagement and Communication

Families can participate in parent teacher conferences, arts performances, school advisory committees, and family nights. Communication is provided through phone alerts, email, and bilingual messages. Some parents have expressed a desire for more consistent follow up on academic concerns

#### 9. Parent Concerns and Suggested Actions

Families with traditional or religious values may wish to consider:

- Clarifying how gender identity policies are applied in early grades
- Reviewing academic support services available for struggling students
- Observing how arts integration affects classroom routines
- Verifying space and time for religious expression if applicable

Recommended next steps for parents:

- Schedule a tour and speak with administration about curriculum and policies
- Request academic progress updates early in the year
- Attend student performances and parent nights for community insight
- Review the student handbook and stay informed on district wide changes
